Program Description

Description

This program offers licensed practical nurses (LPN's), the opportunity to advance their career in nursing. LPN's pursuing this degree must have attended an accredited LPN program and possess a current unencumbered LPN license. To be eligible for the program, applicants must also provide verification of employment indicating a minimum of 2000 hours work experience as an LPN over the last two years. Following application, in order to be seated, those applying must successfully earn credit for prior college level learning (CPCLL) for NSG 117: Medical-surgical nursing.

Program Learning Outcomes

Upon successful completion of this program, students should be able to:

1. Use evidence based practices in the delivery of nursing care.
2. Communicate effectively with individuals, families, communities and the health care team using a variety of methods, including informatics.
3. Utilize the nursing process and standards of care in promotion of health and wellness and in the prevention and management of illness for individuals across the life span.
4. Respect the client's cultural diversity by incorporating professional nursing values of legal, ethical, and caring behaviors through lifelong learning.
5. Collaborate as a member of the interdisciplinary health care team to provide quality care and integrate safety that reduces harm to clients.
6. Integrate critical thinking and clinical decision making to make sound clinical judgments.
7. Advocate on behalf of the client, the family and the community, who are a source of control and full partners when producing compassionate care.

Career Opportunities

Graduates may seek full-time employment upon passing the National Council Licensure Exam for Registered Nurses. Opportunities for employment in nursing exist in hospitals, clinics, home care factories, military services, schools, public health, and education settings. The Bureau of Labor Statistics predicts that employment in nursing will grow 12% between the years of 2018 and 2028. Many more opportunities in nursing are available with advanced education and experience.

Occupational Exposure/Risk

Students in the nursing program must understand that they will be involved in the direct care of clients. Because nurses are required to lift, move and transfer patients, stand for long periods of time, possess certain fine motor skills and sufficient visual acuity to care for patients, additional physical capabilities are required for entrance into the program. In order to be considered for admission to or retention in the Nursing Program, students must possess:

- Sufficient visual acuity necessary for accurate assessment and safe nursing care to clients, such as, physical assessment, preparation and administration of all medications and direct observation of clients.
- Sufficient auditory perception to receive verbal communication from clients and members of the health team and to assess client health status while using equipment and interpreting other noise stimuli (cardiac monitors, stethoscopes, intravenous infusion pumps, dopplers, fire alarms, call lights and cries for help).
- Sufficient gross/fine motor coordination to respond promptly and implement skills required in meeting health care needs of clients, including manipulation of equipment and supplies.
- Sufficient physical abilities to move around client's rooms, work in treatment areas and administer cardiopulmonary procedures.
- Sufficient strength to perform physical activities frequently requiring the ability to lift, push, pull objects more than fifty pounds and transfer objects and persons of more than one hundred pounds.
- Sufficient communication skills (speech, reading, writing) to interact with clients and communicate their health status and needs promptly and effectively.
- Sufficient intellectual and emotional capability to plan and implement care for clients.
- Sufficient psychological stability essential to perform at the required levels in the clinical portions of the nursing program.
- Ability to sustain long periods of concentration to make decisions regarding correct techniques, use of equipment, and proper care of clients.
- Sufficient physical stamina to remain standing for long periods of time.

Applicants considering a career in nursing may also be exposed to infectious diseases during their course of study and in subsequent employment in the field and are likely to work in situations where exposure to infectious disease is possible. This is an occupational health risk for all health care workers. Persons should not become health care workers unless they recognize and accept this risk. Proper education and strict adherence to well established infection-control guidelines can reduce this risk to a minimum. Thorough education in infection control procedures is an important part of the nursing program of study.

Registry / Certification / Licensure Exam Information

The nursing program prepares graduates for entry-level positions in the nursing profession.

Successful completion of the program of study qualifies graduates to receive an Associate in Applied Science Degree and apply to take the National Council Licensure Examination for Registered Nurses (NCLEX-RN) leading to state license as a registered nurse.

The Michigan State Board of Nursing regulates the licensing and can deny RN licensure for a number of reasons; for example, conviction of a misdemeanor or a felony. Prior to beginning the Nursing program, students are advised to visit the [Michigan website](#) or call the Michigan Board of Nursing regarding eligibility for licensing.

Program Completion Limits

The College and the Nursing Faculty reserve the right to make policy and program changes at any time to comply with requirements of accrediting agencies, clinical facilities, or the college, and to meet the changing health care needs of society. Admission Requirements

Admission Requirements and Eligibility

Admission is competitive. The program has a limited enrollment and admits students in the fall and winter semesters. Acceptance into the college does not constitute nor guarantee admission to the nursing program. Final approval to enroll in the program comes from the Dean/Associate Dean of the School of Health and Human Services. To be considered, applicants must:

1. Be admitted to Henry Ford College.
2. **GPA:** Have a cumulative grade point average of 2.70 or better in pre-requisite courses to the Nursing program.
3. **Appointment:** Students must make an appointment with the Nursing Student Success Navigator located in the Welcome Center Advising Area on main campus, within 2 years of application
4. **Application:** Submit a nursing program application with all required documentation by application deadline. Application deadline dates can be found on the [Nursing program website](#).
5. **Grades:** Complete all prerequisite, co-requisite, and support courses with a "C" grade or better. No pre-requisite, co-requisite or support courses can be repeated more than one time to receive a "C" grade (C- is not accepted). Two failures in a required course within five years prior to application deems a student ineligible to apply to the nursing program. High school grades are only valid within 10 years of college admission date. Courses required for program admission:

 - **Other Courses:** Complete: [ENG-131](#), [PSY-131](#), [HCS-131](#) or [CIS-100](#).
6. **Nursing Admission Test (NAT):** Successfully complete the NAT.
 - The required Nurse Admission Test (NAT) is offered by the College and must be taken at HFC.
 - Students are only allowed two attempts every two years, with date beginning on the first attempt. NAT exam must be passed within 3 years of application.
 - The [Learning Lab](#) offers free assistance to prepare for this exam.
 - The NAT requirements are:
 - Math proficiency at 80%.
 - Reading composite proficiency at 80%.
 - Grammar proficiency at 80%.
 - Vocabulary proficiency at 80%.
 - Students unsuccessful on their first test may choose in their second testing attempt to only take those subject areas where a score of 80% was not achieved in their first attempt.

Additional Program Requirements

Nursing program applications must be complete with documentation attached for maximum point value and be submitted at the Nursing Admission Submission session held at the School of Nursing, East Campus, 3601 Shafer Road, Dearborn, MI 48126. Session dates are posted on the [nursing program website](#). Final acceptance is contingent upon fulfilling and maintaining minimum program requirements and proof of the following by specified deadline dates:

- An official transcript from the applicant's practical nursing school
- Proof of a current Michigan LPN license
- Verification of most recent work experience to include at least 2000 hours (equal to one year of full time employment) within the last two years as an LPN
- Submission of a resume (including job description and daily nursing activities)
- Health Insurance
- Physical examination
- TB testing/screening
- Immunizations as required
- Flu vaccination
- Titers to assure immunity for specific conditions
- American Heart Association (AHA) BLS for Healthcare Professionals certification
- Must pass drug screening on first test
- Criminal background check

Specific procedures for the Advanced Placement program may be obtained from the Nursing Student Success Navigator located at the Welcome Center Advising Area on main campus.

Clinical Placements: Each semester courses have clinical assignments in addition to classroom time. Clinical assignments involve direct patient care at various Metro Detroit area agencies. Placements of students in clinical agencies is increasingly difficult to secure. Clinical placements occur in many different agencies and may be during the day, afternoon, evening or weekend. Students who are unable to make arrangements and adjustments in their personal schedules to accommodate meeting clinical requirements at their assigned rotation will need to withdraw from the Nursing program. Applicants must be able to attend any assigned shift or day for their clinical placement.

All educational experiences are under the direction and guidance of the nursing faculty. Student progress is evaluated in the clinical setting, classroom and nursing laboratories. Progression in nursing courses follows the policy written in the Nursing Student Handbook (NSH) and is based on the student's:

1. Adherence to program requirements and policies outlined in the NSH
2. Achievement of the minimum grade of "C" (C- is not acceptable) for all pre-requisite, co-requisite and support courses.
3. Achievement of the minimum grade of "C" (C- is not acceptable) for all nursing courses.
4. Satisfactory clinical performance. Unsatisfactory clinical or lab performance in a course with a clinical component is considered a failure in the course.

Withdrawal and Readmission: Students who do not complete course objectives for personal or medical reasons, receive less than a "C" grade in theory, or who receive a clinical/lab unsatisfactory evaluation for any nursing course are withdrawn from the Nursing Program and do not progress to the next level of course work. Refer to the Withdrawal and Readmission Policy in the NSH.

HFC Nursing Program FAQ's

1. HOW DO I GET STARTED IN THE NURSING ADMISSION PROCESS?

All prospective Nursing students must attend an online Nursing Information Session with Student Success Navigator, Julie Fountain, available through the Nursing website, Admissions page.

2. IS THERE A WAITING LIST?

There is no waiting list at HFC. The top students are admitted each fall and each winter semester based on an admission points system.

3. DO LICENSED PRACTICAL NURSES (LPNs) GET SPECIAL TREATMENT?

LPNs who are interested in the Advancement of LPN to RN program at HFC may submit an application at the same time as general Nursing applicants. They must choose the Advancement of LPN to RN program on the online application. Additional admission documentation is required for this program and LPNs must meet all program criteria to apply. Once an LPN has applied to the program, they are required to test out of NSG 117 Medical-Surgical Nursing I by taking the HESI Fundamentals of Nursing exam. They will have two attempts to pass this exam with a score of 850 or higher. Once passed, the LPN will receive 6 credit hours of Credit for Prior College-Level Learning for NSG 117. A \$50 fee will be assessed for CPCLL. If an LPN does not pass the HESI Fundamentals exam upon two attempts, they are welcome to apply for the traditional RN program during the next application period. Interested LPNs are advised to meet with the Nursing Student Success Navigator.

4. HOW MANY POINTS DO I NEED TO GET INTO THE NURSING PROGRAM?

The point system is designed to take the top students, regardless of point totals. Total points for acceptance in any given application cycle depends on the quality of the pool of applicants. There is no way to predict the minimum number of points that guarantees admission. The point range will vary in each application pool. Points are awarded on the following categories:

*Prerequisite GPA *NAT score *ACT/SAT score *Previous Academic Degree
*Health Related Licensure *# of Credits taken at HFC *Proof of Military Service

5. WHAT ARE MY CHANCES OF ACCEPTANCE?

A higher number of application points increases your chance of acceptance into the program. There is no way to predict a student's probability of admission. It is dependent upon the pool of qualified applicants for that specific semester. The process is competitive and one in which the numbers or quality of the pool of applicants cannot be predicted.

6. WHAT CAN I DO TO INCREASE MY CHANCES OF ACCEPTANCE INTO THE NURSING PROGRAM?

To submit an application you must meet all current minimum Nursing Program admission requirements. Lack of any required documentation will result in your application being marked "ineligible." It is your responsibility to check to make sure that all admission requirements have been met and transferrable credits posted to your record. To increase your chances for acceptance, please contact the Nursing Student Success Navigator for further guidance and review of admission requirements and additional optional point items.

7. SHOULD I TAKE THE ACT OR SAT EXAM? SHOULD I REPEAT THE ACT OR SAT EXAM TO IMPROVE MY SCORE?

Not everyone has taken the ACT or SAT Exam. If you have not taken either test, you can choose to do so. ACT and SAT preparation guides are available in most bookstores. If you choose to repeat either test to improve your score, the College will take the higher score achieved, so there is no risk in repeating the test. Exam scores must reach the college by the application deadline. A minimum of 18 on the ACT must be achieved to earn points. To obtain official ACT scores, contact www.act.org or your high school. A minimum of 860 must be achieved on the SAT to earn points. To obtain your scores, contact www.collegeboard.org.

8. WHEN SHOULD I TAKE THE NURSING ADMISSIONS HESI (NAT 100) TEST?

Admissions Test (NAT 100 - also known as the HESI A² exam) must be passed within three years of date of application. It must be taken at HFC and **a score of 80% must be achieved on four subject areas:** Math, Reading, Grammar, and Vocabulary to be eligible for program admission. Students unsuccessful on their first test may choose in their second testing attempt to only take those subject areas where a score of 80 was not achieved in their first attempt. After a second unsuccessful attempt, a student must wait two years from their first attempt to test again. It is suggested that students take the NAT exam prior to or early in their pre-requisite course work to assure they meet all requirements to enter the program. Important Note: virtual testing with a proctor on Zoom is planned for the Fall 2021 admission cohort; a personal computer with a camera will be required to test. NAT 100 exam dates may fill up early; please register well in advance of your anticipated application date. If you do not present on the test date, objectives not met (ONM), will be entered for the exam, this will denote one NAT failure. This applies to both first and second attempts of the NAT 100.

9. SHOULD I REPEAT ANATOMY AND PHYSIOLOGY COURSES?

A passing grade of C or better in Anatomy and Physiology I and II are valid if completed within five years of application to the Nursing program. If taken between five and ten years prior to application, you may repeat A & P I and/or II or you may be eligible for Biology 134 – a "refresher" course (only offered in Fall & Winter semesters). NOTE: prerequisite GPA will be calculated on original BIO 233 grade. If taken more than 10 years prior to application, you must repeat both courses. Before registering, consult with the Nursing Student Success Navigator to select the appropriate course(s).

10. DOES MY VOLUNTEER OR WORK EXPERIENCE HELP?

Documentation of volunteer hours and/or letters of recommendation do not earn additional application points and are not generally considered during the application review process. LPNs must upload the verification of LPN employment form along with their online Nursing application.

11. HOW MANY STUDENTS ARE ADMITTED EACH YEAR?

Approximately 100 -110 students are accepted in both the Fall and Winter semesters. When an accepted student declines the invitation to start the program, he or she must re-apply if they wish to pursue admission in a future semester.

12. WILL I BE ACCEPTED WITH A "C" IN ANY PROGRAM-REQUIRED COURSE?

You are eligible to apply with a minimum grade of "C" in pre-requisite courses; however, admission GPA requires a minimum of 2.7 on program pre-requisite courses. Requisite courses can only be attempted twice. Two failures in a required course within 5 years prior to application makes you ineligible to apply to the program.

13. HOW DO I KNOW IF I HAVE EVERYTHING COMPLETE AND I AM ELIGIBLE TO APPLY?

We recommend that you schedule an appointment with the Student Success Navigator for Nursing, Julie Fountain, to review application and program requirements well in advance of the application deadline. Prospective LPN to RN students must submit a copy of their current unencumbered LPN license, a resume, and a verification of employment form, available on the Nursing website, documenting a minimum of 2000 work hours as an LPN. It is your responsibility to ensure that your application is complete including all required supporting documentation. You may contact Ms. Fountain at 313-317-6807 or jafountain@hfcc.edu.

14. WHEN CAN I APPLY TO THE NURSING PROGRAM?

Once all pre-requisite courses are complete and admission criteria is met, students may complete an online application available at <https://nursing.hfcc.edu/admissions>. Applications must be complete with all required supporting documents – incomplete applications will not be considered. Applications can be submitted online **April 1 through May 30** for Fall admission; and **August 1 through September 30** for Winter admission.

15. CAN I EARN POINTS FOR A PREVIOUSLY-EARNED DEGREE OR HEALTH-RELATED CERTIFICATION OR LICENSE?

Yes, students can earn points based for a previously earned Associate, Baccalaureate, or Master's degree; and for current certification or licensure as a Certified Nursing Assistant, Certified Medical Assistant, Licensed Emergency Medical Technician, Licensed Respiratory Therapist, and Registered Physical Therapy Assistant. Documentation must of the above must be uploaded into the application system to received application points. No documentation = no additional points.

16. WHAT IF I FAIL A REQUIRED COURSE TWICE?

Two failures in a required course will deem a student ineligible to apply to the Nursing program for five years from the date of the first failure. A student can apply for academic forgiveness through the Registration and Records after five years have passed from the first failure.

17. ARE THERE ANY OTHER REQUIREMENTS FOR PROGRAM ADMISSION BESIDES PRE-REQUISITE COURSES, THE NAT 100 (HESI A²) EXAM and the NURSING INFORMATION SESSION?

Once admitted to the program, there are physical, psychological, and sensory requirements that are necessary for patient care at clinical agencies as part of their course work. This includes providing intimate care for patients of the opposite sex. In order to participate in clinical experiences, students must pass a criminal background check, pass a 10-panel drug screen, obtain a physical exam, provide immunization documentation, meet minimum age requirements, and obtain Basic Life Support (BLS-C) certification and health insurance coverage. LPNs to RN candidates must pass the HESI Fundamentals of Nursing exam with a score of 850 or higher upon two attempts to be admitted to the Advancement of LPN to RN program.

18. WHAT ARE YOUR NURSING PROGRAM STATE BOARD PASS RATES?

The latest report from the State of Michigan (July 2020) indicates an **84.11% pass rate** for HFC first-time testers on the NCLEX-RN licensure examination.

19. WHAT IS MY CHANCE OF FINDING A JOB UPON GRADUATION?

Opportunities for employment in nursing exist in hospitals, clinics, home care, factories, military services, schools, public health, and education settings. The Bureau of Labor Statistics predicts that employment in nursing will grow 12% between the years of 2018 and 2028, much faster than the average for all occupations. Advancement of LPNs to RN Program Advising Worksheet - Fall 2021 Admission

STEP 1 – Apply for admission to Henry Ford College online at www.hfcc.edu. If you have previously attended HFC, you need not re-apply. Students must satisfy admission requirements for the college.

STEP 2 - Review program requirements outlined in the college catalog including physical, psychological, and sensory requirements. These are necessary to fulfill course requirements encompassed in patient care at clinical agencies. Once admitted to the program, students must pass a criminal background check, pass a 10-panel drug screen, obtain Basic Life Support (BLS-C) certification and health insurance coverage, clinical health requirements including immunizations and annual Influenza vaccine, and meet minimum age requirements.

STEP 3 - Qualify for admission by completing the following requirements.

- ___ Attend a mandatory Nursing Program Information Session with Student Success Navigator within two years prior to application submission
- ___ Nursing Admissions Test (NAT 100/HESI A²)
Score of 80% or higher on four subjects: Math, Reading, Grammar, Vocabulary
- ___ Complete the following pre-requisite courses with a grade of “C” or better (C- not acceptable):
 - BIO 233 (must be completed within 5 years prior to nursing program application; if older than 5 years, consult with an advisor)
 - ENG 131
 - PSY 131
 - Math (select one) 115, 131, 141, 165, 175, 180
 - Computers (select one) HCS 131, CIS 100
 - Minimum 2.7 GPA on above courses

Co-Requisite Requirement:

If not completed within 5 years prior to program application, one non-Nursing co-requisite, BIO 234, must be taken during the first semester of the program. If completed more than 5 years prior to application, consult with an advisor. It is highly recommended to complete BIO 234 prior to Nursing program admission.

No pre- or co-requisite, non-nursing support can be repeated more than once to receive a “C” or better grade. Two failures in a required course, whether taken at HFC or elsewhere, within five years prior to application deems a student ineligible to apply to the Nursing program. Students may repeat courses multiple times to achieve a higher grade as long as the previous grade was a C or better.

Students wishing to transfer credits from another institution should send an official transcript to:

All transfer credits must be posted to student's HFC transcript prior to application submission. Official transcripts from other institutions attended should be submitted to Registrar@hfcc.edu a **minimum of 4 weeks** prior to the application deadline. Transcripts received after that time frame may not be evaluated in time to meet application deadline. The Registrar will not award transfer credit for a course successfully completed with a “C” or better from another institution that was taken at HFC prior to 2014 where a C- or lower was received.

STEP 4 – Apply to the Nursing Program
Application Deadline for Fall Admission: May 30
Application Deadline for Winter Admission: Sept. 30
Nursing Program application is available online at <https://nursing.hfcc.edu/admissions>. Applications must be complete with all required supporting documents (including current LPN license, resume, and employment verification form) and submitted online by the posted deadlines for Fall or Winter admission. Incomplete applications will not be accepted. Applicants are ranked by point totals within the application pool. Points are calculated primarily on GPA on pre-requisite courses. Once an LPN has submitted an application, he/she will be contacted to take the HESI Fundamentals of Nursing exam. LPNs have two attempts to pass this exam with a score of 850 or higher. Once passed, the LPN will receive 6 credit hours of Credit for Prior College-Level learning for NSG 117 Medical-Surgical Nursing I. A \$50 fee will be assessed. If unsuccessful, the LPN can reapply to the general RN program during the next application period. Admission is contingent upon academic performance and other criteria and can be revoked for unsuccessful subsequent academic performance or violation of HFC policy. Admission is not guaranteed to all applicants who meet minimum requirements.
