

# Henry Ford College Nursing Program Advising Worksheet

FALL 2018 Admission

**STEP 1 – Apply for admission to HFC** online at [www.hfcc.edu](http://www.hfcc.edu). If you have previously attended HFC, you need not re-apply. Students must satisfy admission requirements for the college.

**STEP 2 - Review program requirements outlined in the college catalog** including physical, psychological, and sensory requirements. These are necessary to fulfill course requirements encompassed in patient care at clinical agencies. Once admitted to the program, students must pass a criminal background check, drug screen, and meet minimum age requirements.

**STEP 3 - Qualify for admission by completing the following requirements.**

- \_\_\_ Attend mandatory Nursing Program Information Session with Student Success Navigator for Nursing
- \_\_\_ Nursing Admission Test (NAT) exam score of 80 or higher on math, reading, vocabulary and grammar. Students are only allowed two attempts every two years. NAT exam must have been taken within three years of application.
- \_\_\_ BIO 233 (must be completed within 5 years prior to nursing program application; if older than 5 years, consult with an advisor)
- \_\_\_ ENG 131
- \_\_\_ PSY 131
- \_\_\_ One of the following: Math 115, 131, 141, 175, 180
- \_\_\_ HCS 131 or CIS 100
- \_\_\_ Minimum 2.7 GPA on above courses

- \*Suggested book: HESI Exam Review 4th Edition
- \*Additional study materials available at Learning Lab
- \*Register for NAT 100 (HESI exam) via WebAdvisor
- \*NAT 100 prep workshops available

All pre- and co-requisite, non-nursing, and nursing courses must be passed with a "C" grade or better. **No pre-requisite, non-nursing support can be repeated more than one time to receive a "C" or better grade (C- not accepted). Two failures in a required course within five years prior to application deems a student ineligible to apply to the Nursing program.**

All transfer information must be formally submitted to the Registrar's Office.

**Points will be tabulated based primarily on GPA and HESI/NAT Exam score.** Applicants are admitted based on point totals, highest to lowest within the application pool. Admission is contingent upon academic performance and other criteria. Admission can be revoked for unsuccessful subsequent academic performance or violation of HFC policy.

### Co-Requisite Requirements:

**Students MUST successfully complete the following requirements along with their nursing courses to graduate from the Nursing Program.** These courses can be completed once admitted to the Nursing Program if completed as indicated in the program course sequence outlined in the Nursing Student Handbook.

- \_\_\_ BIO 234 may be completed within 5 years prior to nursing program application (or during 1st semester of NSG program)
